**INDEPENDENT PRACTITIONER'S ASSURANCE REPORT**

Pursuant to the conditions stated in the Public Subscription Permit issued by the Social Welfare Department of the Government of the Hong Kong Special Administrative Region ("SWD"), I have been requested to report on the attached income and expenditure account of the Permittee's territory-wide flag day fund-raising activities held on 14th May 2022 ("the Event").

**Responsibilities of the Executive Committee Members**

The work undertaken in connection with this engagement is less in scope than an audit conducted in accordance with Hong Kong Standards on Auditing and consequently does not enable me to obtain assurance that I would become aware of all significant matters that might be identified in an audit. Accordingly, I do not express an audit opinion.

My engagement included carrying out limited procedures for obtaining sufficient appropriate evidence to be able to draw a conclusion, such as inquiries primarily of persons responsible for financial and accounting matters, analytical procedures applied to financial data and other procedures I considered necessary. The procedures performed in a limited assurance engagement vary in nature and timing from, and are less in extent than for, a reasonable assurance engagement. Consequently, the level of assurance obtained in a limited assurance engagement is substantially lower than the assurance that would have been obtained had a reasonable assurance engagement been performed.

**Inherent Limitations**


Due to the nature of cash receipts and expenses relating to the Event, it was not practicable for me to determine whether the income and expenditure account and the books and records of the Permittee include all transactions relating to the Event. It was impracticable for me to quantify the potential impact of this on the income and expenditure account. Accordingly, my report relates solely to the income and expenditure account prepared from transactions that have been recorded in the Permittee's books and records.

**Conclusion**

Based on the foregoing, I report that nothing has come to my attention that causes me to believe that the attached income and expenditure account does not reflect, in all material respects, the gross subscriptions raised and the expenses incurred by the Permittee in respect of the Event that have been recorded in its books and records made available to me in accordance with the basis of preparation set out in Note 1.

**Intended User and of Purpose**

This report is intended solely for the purpose of assisting the Permittee to satisfy the conditions stated in the Public Subscription Permit issued by SWD in connection with the Event and is not intended to be, and should not be, used for any other purpose. I agree that a copy of this report may be provided to the Director of Social Welfare without further comment from me.

1. General information

The Permittee was incorporated in Hong Kong under the Hong Kong Companies Ordinance as a Hong Kong company limited by guarantee and not having a share capital. The registered office of the Permittee is located at 61, Lung Kong Road, Kowloon City, Kowloon, Hong Kong.

2. Basis of preparation

The purpose of the territory-wide flag day fund-raising event is for supporting the Permittee's primary care medical services and charitable social welfare services, including ethnic minority supporting services, speech therapy, rehabilitation service centres, free meal services for the deprived, child development funds and other services.

The income and expenditure account has been prepared in accordance with accrual basis of accounting.

The significant accounting policies are set out below:

(a) Revenue recognition

(i) Flag day collections

Public Subscription Permit issued by SWD authorizes the Permittee to conduct the Event by moving around solicitation with money collection bags. Proceeds from the Event are recognized when received; and

(ii) Other donations

Other donations through the Permittee's internal appeals for the Event and proceeds from the Event are recognized when received.

3. Donations credited to the bank

All the territory-wide flag day proceeds collected \$1,425,802.00 have been credited to the designated bank account of the Permittee before being used for payment of expenditure for territory-wide flag day and the purposes specified in the permit on 12th July 2022.
